# **SMEATON**

Budget	\$1.6 million
Client	Suncorp
Size	1000m²

A granary in Smeaton, a rural town located 132km

North West of Melbourne suffered an explosion
to one of the boilers used to produce steam and
process grain. This site had restricted access for
dedicated machinery, requiring strategic thinking
to allow specialists to access the damaged silo and
carryout internal works via crane to abseil trades.


Works were undertaken in various stages by
moving grain through adjoining silos to ensure the
granary maintained operation during the
project.



# **EMC**

Budget	\$400,000

Comprehensive test facility located in Keilor Park
17 km north-west of Melbourne's central business
district, had sustained flooding to the main testing
room affecting the dynamics of the room when
put under extreme pressure. Insuraplex removed
the whole internal components of the testing
room and rebuilt from the ground up to meet
accreditation.



# LEVANSWELL

Moorabbin is a suburb located 15 km south-east of Melbourne's central business district. Most of the eastern side of Moorabbin has been an industrial area since the first development in the mid-1960s and is also well known locally for its residential area built after World War II.

The factory required structural steel replacement under urgent make safe before progressing to a full internal repairs.



# SKM RECYCLING PLANT

Budget	\$5 million
Client	SKM
Size	1800m²

David Cameron was a crucial element to this project, reinstating four factories that burnt down. The fire reinstatement cost approximately \$5 million dollars. The rebuild included all services and structural components, including removal and salvage of \$20 million worth of equipment.

This was David's second rebuild of the facility, after a similar fire whilst working for Johns Lyng Group.



# **PAKENHAM**

In the heart of Pakenham a substantial fire put the local social mecca at risk. Destroying majority of the upstairs level, the fire tore through the business and left a myriad of restoration works.

Insuraplex restored the entire top level, room by room including bedrooms, kitchens, bathrooms, staircases - whilst ensuring the downstairs operations continued.



# THOMASTOWN

Located in a busy industrial area, this factory suffered significant fire damage as a result of a careless tenant. The premises required full structural steel replacement followed by entire internal fitout. We were challenged with the removal of a large silo at the rear of the property which required a crane to remove it. Overall this project was completed in a smooth manner and exceptional time frame for a job of this size.
